

# Fike/DuPont Sustainability Warranty

## Limited Warranty

Fike and DuPont warrant, for a period of 20 years after original installation and subject to the service and registration requirements below, that:

1. DuPont™ FE-227™ and DuPont™ FE-25™ (also known as HFC-227ea and HFC-125) chemical clean agents installed in an approved\* fire suppression system or equipment will not be restricted from use in fire protection due to their Ozone Depletion Potential (ODP) or Global Warming Potential (GWP). In the event that a regulation is enacted after purchase and installation of a new system using FE-227 or FE-25 from Fike that prohibits the use of these agents for fire protection, Fike and DuPont will replace the agent with one that meets the new environmental regulations or refund the original purchase price of the agent. These choices are Fike's and DuPont's. The remedy does not include labor or other costs associated with restoring the original system to an operational state.
2. A) FE-227 and FE-25 chemical clean agents will not contribute to internal corrosion of the cylinders in which they are contained.  
  
B) A discharge from a properly designed FE-227 and FE-25 clean agent fire protection system will not leave residue on protected assets that directly causes asset malfunction.  
  
C) FE-227 and FE-25 will not react with water and are compatible with water-based fire protection systems.

In the event that a Fike supplied system fails to comply with above items 2A, 2B and/or 2C, Fike and DuPont will repair or replace the clean agent system to meet these performance requirements, at the discretion of Fike and DuPont.

\*"Approved" means the system or equipment complies with CEN 14520, CEA 4009, VDS 2381, UL 2166 or other third-party accreditations, which other accreditations have been accepted by Fike and DuPont in writing prior to commissioning.

## Installation and Service Requirement

This warranty is provided only to the original purchaser/user of the FE-227 or FE-25 system. It is not transferable or assignable. It applies only to fire protection systems that are designed, installed, and commissioned by an authorized Fike distributor, and that use hardware, components, controls, and detection devices provided by Fike. The original purchaser must maintain a semiannual service agreement with an authorized Fike distributor from the date of installation. In no event will the warranty extend beyond the 20-year period. This warranty is void if, after any discharge, the system is not refilled with new FE-227 or FE-25 agent by Fike or a Fike authorized distributor.

## Registration Requirement

This warranty is not effective unless the original purchaser registers the system directly with Fike using Warranty Registration Form FDWS-0710 within 30 days after commissioning. The form can be obtained from a Fike regional sales manager or by calling 816-229-3405. No further registrations are required.

## LIMITATION OF LIABILITY

THE SOLE RESPONSIBILITY OF FIKE AND DUPONT IS REPLACEMENT OF THE FE-227 OR FE-25 CLEAN AGENTS, OR REPAIR OF NON-COMPLYING PARTS AND COMPONENTS, OR REFUND OF THE ORIGINAL PURCHASE PRICE OF THE AGENT, AT THE OPTION OF FIKE AND DUPONT. Except as provided above, FIKE AND DUPONT MAKE NO WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER IMPLIED WARRANTY. FIKE AND DUPONT SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL, OR SIMILAR DAMAGES.
